Introduction

Cascale is committed to activating our ecosystem for action. We believe that setting and working towards science-based targets (SBTs) collectively provides a crucial and aligned pathway for the industry to reduce greenhouse gas (GHG) emissions and limit global warming to 1.5°C. These are objective goals backed by the latest climate science on our most advanced understanding of how GHG emissions impact the climate.

Through our manufacturer climate action program (MCAP), Cascale is providing a platform for manufacturers - Cascale members and nonmembers - to set science-aligned climate change targets for scope 1 and 2 emissions that are aligned with the criteria of the Science Based Targets Initiative (SBTi). MCAP includes criteria, tools, and guidance to support manufacturers to set targets, take action, and report on progress. MCAP is only available to manufacturers, and it allows Cascale manufacturers to meet Cascale membership requirement to have a science-based target.

Note that the terminology "science-aligned target" is meant to distinguish what is required under MCAP versus under the SBTi. The primary difference is that SATs under MCAP do not include scope 3 emissions The criteria and requirements are generally the same across MCAP and the SBTi, with minor differences noted in the MCAP criteria and recommendations document.

Committing to Set Science-Aligned Targets through MCAP

Step 1 - Sign and submit the MCAP commitment letter

Signing the Commitment Letter indicates your company is committed to set SATs aligned with MCAP requirements and criteria, which in turn are based on those of the SBTi. Once signed, submit your e-letter to Cascale through email. We will acknowledge receipt of your submission within 1 week.

Step 2 - Develop a target

Once your company has signed and submitted the commitment letter to Cascale, you have up to 12 months from the signed commitment date to develop and submit your SAT for validation. Cascale has prepared a number of resources to support companies in the MCAP process, and resources from the SBTi may also be useful.

Step 3 - Submit your targets for official validation

To have your target validated, you must complete the MCAP target submission form, and email it with any supporting documents to Cascale. Cascale has contracted with third party experts to validate targets, and these experts will evaluate targets based on the MCAP criteria and recommendations document. Once targets are submitted, Cascale will acknowledge receipt, and then initiate target validation with one of the approved third-party validators. It is likely that the validator will have questions of clarification on the target, and so there may be email correspondence to clarify questions. Cascale aims for the validation process – from target submission to a decision on target approval – to take no more than two months.

Step 4 - Announce the target

Once your company and Cascale receives confirmation from one of the third-party validators that your target meets the MCAP's criteria, Cascale will announce your targets through the MCAP website and other communication channels.

We are committed to joining the growing number of leading companies that are setting science-aligned targets in line with latest climate science in order to reduce GHG emissions. Thus, we recognize the crucial role that the apparel, footwear and textile sector and other adjacent industries can play in reducing the impact of climate change.
